- 3. A person shall not be qualified for being engaged as an apprentice to undergo apprenticeship training in any designated trade as per Apprentices Act, 1961, unless he/ she:
 - a) is not less than fourteen years of age, and for designated trades related to hazardous industries, not less than eighteen years of age; and
 - b) satisfies such standards of education and physical fitness as may be prescribed: Provided that different standards may be prescribed in relation to apprenticeship training in different designated trades [and for different categories of apprentices].

4. General Conditions:

- a) The date of determining qualification shall be the date of Walk-in Interview.
- b) Candidates must bring the original certificates in respect of age/ educational qualification etc., at the time of Walk-in- Interview. Candidates coming with incomplete application, without photo, Photocopies of certificates, testimonials and not bringing original documents for verification will not be allowed.
- c) Only those candidates who possess the qualifications will be permitted to attend Walkin Interview.
- d) Passed out trainees in the particular trade of NCVT pattern designated by Director General of Employment & Training (D.G.E & T) and who have registered with Regional Directorate of Apprenticeship Training, Chennai/ Govt. RI Centres will only be considered for selection.
- e) Candidates should have to be registered with apprenticeship web portal i.e. https://www.apprenticeshipindia.gov.in/
- f) Successful candidates will be awarded National Apprenticeship Certificate by National Council for Vocational Training.
- g) Candidates already undergoing/ undergone Apprenticeship Training are not permitted to attend the Walk-in Interview.
- h) Candidates found suitable for selection will be empaneled. Empaneled candidates may be selected for future requirements of the Institute.
- i) Applications in a format, other than in the enclosed prescribed Application form, will not be considered.
- j) Candidates Should **NOT** send their applications by post/ speed post/ courier.
- k) Incomplete application form without requisite information, certificates/ documents, photograph are liable to be rejected.
- I) Any discrepancy found in the information given in application and that is evident in original documents will make the candidate ineligible for appearing for interview.
- m) If at any subsequent date it is detected/ found that the candidates have given incorrect information or has withheld certain information or does not fulfill the eligibility criteria; their candidature shall be cancelled without assigning any reason whatsoever.
- n) Candidates, in any case, will not be allowed to report for Walk-in interview beyond 11:00 AM.
- o) Final year students and those who are awaiting for results are **NOT ELIGIBLE** to be considered.
- p) In case of selection, Original certificates must be again produced for verification at the time of joining.
- **5. Reservation:** As regards reservation, all things being equal, SC/ ST/ OBC/ Persons with Disabilities candidates may be given adequate representation so as to ensure their participation.
- 6. Eligible and interested candidates are informed to bring their applications (attached below) along with recent passport size photograph enclosing attested copies of certificates and testimonials and Walk-in for Interview scheduled on 27.09.2024 between 09.00 AM and 11.00 AM at CSIR- Central Leather Research Institute (CLRI), Sardar Patel Road, Adyar, Chennai- 600 020.
- 7. No travelling allowance will be paid for attending the Walk-in Interview.
- 8. Document/ Certificate furnished in a language other than Hindi or English, must be accompanied with an English transcript of the same duly attested by a Gazetted Officer or Notary.
- 9. The Director, CLRI has a right to amend, delete and add terms & conditions to this notification.

- 10. The Director, CLRI reserves the right to cancel the notification without assigning any reason thereof or reserves the right not to fill up the positions. The number of positions indicated against each position is provisional and may increase or decrease at the time of selection.
