Bharat Heavy Electricals Limited (BHEL), India's premier engineering and manufacturing enterprise provides World Class Products and Services and caters to core sectors of the Indian economy viz., Power Generation and Transmission, Renewable Energy, Defence, Aerospace, Oil & Gas with over 180 product offerings to meet the needs of these sectors. BHEL has a widespread network of 16 Manufacturing Facilities, 02 Repair Units, 04 Regional Offices, 08 Service Centres, 1 Subsidiary, 3 active Joint Ventures, 15 Regional Marketing Centres, 3 Overseas Offices and current project execution at more than 150 project sites across India and abroad.

BHEL, Power Sector is looking for **WELDER (on Fixed Tenure Basis).** These candidates shall be trained on Company Costs for acquiring **IBR CERTIFICATION** and subsequently will be offered engagement as **WELDERS** purely on **Fixed Tenure Basis** for an initial period of **24 months** at BHEL's Project Sites anywhere in India. This tenure may be extended upto 12 Months at a time, subject to performance and requirements. The nature of engagement involves stationing at BHEL FSIP, Jagdishpur Unit with subsequent deployment at various project sites during the course of the tenure. This engagement shall be purely on Fixed Tenure Contract Basis and shall not confer any right for permanent employment or regularization in BHEL.

JOB DESCRIPTION:

The IBR Certified Welders will be required to perform the following tasks/activities during the course of their engagement:

- **High-Precision Welding:** Perform specialized welding tasks (arc welding, gas torch welding, plasma cutting) on power plant equipment and piping as per strict safety and technical specifications.
- Work at Heights: The role requires to carry out welding and other related tasks at significant heights (up to 100 meters) on power plant constructions and repairs, adhering to all safety protocols.
- **Material Preparation:** Prepare materials, fit components, and align structures for welding by interpreting technical drawings and specifications.
- Welding Operations: Operate and maintain welding equipment safely and efficiently in various site conditions, including confined spaces.
- **Electrode Handling:** Select and handle different types of welding electrodes as needed for the task, ensuring proper welding materials and techniques are applied.
- Visual Inspection: Conduct visual inspections of welded surfaces and joints, ensuring that the welding complies with quality standards, safety regulations, and customer specifications.
- **Repair & Maintenance:** Perform repair, maintenance, and welding modifications on various thermal power equipment and piping systems when necessary.
- Safety & Compliance: Follow all workplace safety protocols, including the use of personal protective equipment (PPE), and ensure compliance with site regulations.
- **Documentation:** Maintain accurate records of work performed, welding processes used, and inspections conducted.

UPPER AGE LIMIT: 30 years (As on 01.10.2024)

Upper Age limit is relaxable by:

- Relaxation for Ex-Servicemen will be as per extant Govt. Rules
- 3 Years for OBC (Non-Creamy Layer)
- 5 Years for SC/ST
- 5 years for the candidates who had ordinarily been domiciled in the state of Jammu & Kashmir during the period from 01/01/1980 to 31/12/1989.

As reservation for Ex-Servicemen (14.5%) is on horizontal basis, the vacancies will be filled and adjusted in the appropriate category viz., UR/OBC/SC/ ST/EWS.

No reservation for any other category would be applicable other that mentioned above.

<u>Note</u>: The number of vacancies being tentative, the reserved status is only indicative and the number of vacancies in each category may undergo revision in that eventuality.

- Vacancies reserved for **OBC category** are meant only for candidates coming under "Non Creamy Layer". The OBC candidates who do not belong to Non-Creamy Layer should indicate their category as "UR" only.
- The persons belonging to EWSs who, are not covered under the scheme of reservation for SCs, STs and OBCs shall get 10% reservation in direct recruitment in civil posts and services in the Government of India. REMUNERATION & OTHER BENEFITS:

Compensation per month during Training (for upto 3 Months):

All-inclusive consolidated amount of Rs. 15,000/- p.m. is payable during the period under IBR Training.

Compensation per month on Fixed Tenure Appointment:

Rs. 42,500/- p.m. consolidated amount is payable during fixed tenure.

In addition to the consolidated compensation payable per month, Quality incentive (maximum Rs 10000 per month, subject to meeting quality standards) and Productivity incentive (subject to number of joints welded above the standard benchmark) will also be payable.

Note:

- Quality performance will not be considered satisfactory, if defect free water wall equivalent joint per month are less than 95%.
- Productivity performance will not be considered satisfactory, if less than 250 no equivalent Joint of Water Wall Joints, are done in a month.
- If either Quality performance or Productivity performance is not found satisfactory, then the FTA will be under observation for improvement in performance (250 no. equivalent Joint of Water Wall joints with 95% defect free welding per month) for the next 15 Days, otherwise their contract will be terminated.

Medical Benefits:

The premium of Mediclaim policy to be availed by appointee for Rs. 5 lakhs for self, spouse and dependent children will be reimbursed.

Joining TA:

While joining the appointee is eligible for II Class Sleeper train fare for self.

SELECTION PROCESS:

All eligible applications received will be screened with reference to the advertised educational qualification and experience in welding and will be considered for further process.

In the event of eligible candidates being large, they will be shortlisted for **Skill Test** in the ratio of 1:5 to the number of vacancies, in order of merit to the number of vacancies in each category. The merit will be **based on the marks received in ITI & NAC (Weightage of 50% to ITI Marks,**

25% to NAC Marks) & marks for qualifying Experience (25% Weightage). All applicants with each additional six months of qualifying experience (over and above the minimum prescribed of 2 years) shall be awarded 2.5 Marks, limited to a maximum of 25 Marks. Over and above, IBR Welders having valid IBR certificate with a minimum validity of up to 06 Months (as on 01.10.2024) will be given 10 additional marks. IBR Welders with an expired IBR Certificate or less than 6 Months validity shall be given 05 additional marks.

- For shortlisting as per 1:5 ratio, initially, all UR candidates along with such reserved category (i.e. EWS, OBC, SC, ST) candidates of that discipline, who do not avail any relaxation, will be grouped together and then arranged in descending order of merit of their (NTC + Experience) marks and candidates shall be called for Skill Test in the ratio of 1:5 in UR category.
- After this, candidates belonging to EWS/OBC/SC/ST categories, who are not shortlisted for Skill Test under UR category, shall be regrouped with their respective categories for further consideration and will be called for Skill Test in prescribed ratio of 1:5 in their respective categories

In case of candidates obtaining same cut-off marks in respective categories, the younger candidate shall be given preference. However, total count of candidates shortlisted for skill test shall not exceed 250 numbers.

The Skill test for the shortlisted candidates will be conducted at **BHEL designated place**.

The skill test will require the candidate to present themselves at venue and also required to stay for 3 to 4 days at their own cost, as such candidates shall also be required to undergo Medical Examination.

However, candidates shortlisted for skill test will be reimbursed to and fro II Class Sleeper train fare from mailing address or the starting station, whichever is nearer to the place of skill test by the shortest route, on production of proof of journey.

MEDICAL STANDARDS:

Applicants should possess sound health. Before being selected, shortlisted candidates will have to undergo medical examination by the Company's Authorized Officer and the final selection will be subject to medical fitness as per prescribed medical standards for the post.

On being declared medically fit:

- Candidates not having IBR certification would be required to undergo IBR Welder training at BHEL designated place. On successful completion of the training & IBR certification they will be offered engagement as WELDERS purely on Fixed Tenure Basis.
- 2. IBR Welders will be offered engagement as WELDERS purely on Fixed Tenure Basis.

Service Agreement Bond

Trainee Welders shall be trained on Company Costs for acquiring IBR CERTIFICATION and subsequently will be offered engagement as WELDERS purely on Fixed Tenure Basis for an initial period of 24 months at BHEL's Project Sites anywhere in India. This tenure may be extended upto 12 Months at a time, subject to performance and requirements. These Trainee Welders shall be required to execute a Service Agreement Bond of **Rs 4 lakhs** to serve the company on Fixed Tenure Basis **for a period of 3 Years** on successful completion of training

Welders who are already IBR certified will be offered engagement as WELDERS purely on Fixed Tenure Basis for an initial period of 24 months at BHEL's Project Sites anywhere in India. This tenure may be extended upto 12 Months at a time, subject to performance and requirements. These Welders shall be required to execute a Service Agreement Bond of **Rs 3 lakhs** to serve the company for a **period of 3 years**.

GENERAL INSTRUCTIONS:

- The posts are purely temporary in nature and offered on fixed tenure basis for Two year (24 months). This post is not against any permanent vacancy. This placement will not entitle the candidate for any regular / permanent employment in BHEL in future.
- 2. Candidates should possess the required Job Specifications as on 01.10.2024.
- 3. Candidates must have 2 Years' of experience in welding, after apprenticeship period. Experience should be exclusive of Trainee/ Apprenticeship period, if any.
- 4. Candidates should be able to furnish their relevant educational and Post Qualification Work-Experience certificates at the time of reporting for skill test.

After remittance of Fee through SB Collect, please note down the SB Collect Reference Number for filling the fee remittance details in the Online Application. Printout of e-Receipt for State Bank Collect Payment also need to be taken and submitted along with the downloaded application form.

- 6. However, SC/ST and Ex-Servicemen candidates are exempted from paying the processing fee but will still be required to send their application form to the address mentioned, in Point No.10.
- 7. Category such as OBC, SC, ST & EWSs should be carefully filled-up in the online application format as this will not be allowed to be changed at a later date. OBC candidates who do not belong to Non-Creamy Layer should submit their application under **Unreserved** category only.
- 8. Candidates applying under **EWSs** category should fulfil the conditions stipulated for applying under '*Reservation for Economically Weaker Sections (EWSs) in civil posts and services in Government of India*' issued vide DoPT OM dt.19/01/2019. Such candidates should attach the requisite certificate certifying their "*Income and Asset of the family*"

in the prescribed format (as available in our website), from an officer not below the rank of Tehsildar, along with their application and at the time of interview.

- 12. Candidates are advised to possess a valid e-mail ID which is to be entered in the online application Form. They are also advised to retain this e-mail ID active for at least one year as any important intimation to the candidates shall be provided by BHEL through e-

mail. They are further requested to **check their e-mails regularly** for any communication from BHEL in this regard.

- 13. Applications not in conformity with the requirements indicated in the advertisement, incomplete applications and those applications not with requisite attachments will not be entertained.
- 14. Candidates are required to enclose self-certified copies of all the relevant documents in support of date of Birth, Qualification, Experience, Category Certificate, latest pay slip etc., along with their applications. However, supporting documents in original as prescribed will be required for verification at the time of reporting for skill test.
- 15. In case it is found at any stage of the selection process or even after appointment that the candidate has furnished false or incorrect information or suppressed any relevant information/material facts or does not fulfil the essential eligibility criteria, his/her candidature / service are liable for rejection/termination without notice.
- 16. Management reserves the right to restrict the number of candidates to be called for skill test, reject the application without assigning any reason/change the number of posts / raise the standard of specification.
- 17. No correspondence will be entertained with the candidates not invited/ selected for skill test.
- 18. Only Indian Nationals need to apply.
- 19. Interim inquiries will not be attended to and any form of canvassing will be a disqualification and will render the candidate ineligible for selection.
