Indian Statistical Institute, an Institute of National Importance under the aegis of the Ministry of Statistics and Programme Implementation (MoS&PI), Government of India, invites applications from eligible Indian nationals for recruitment to the following vacant posts for its Headquarters in Kolkata and other Outlying Centres, Branch and Units.

1. ELECTRICIAN A

Qualification & Experience: School Final or equivalent with ITI certificate or equivalent and with permit equivalent to Electrical Wireman's class (i) (b), (ii), (iii), (iv).

2. OPERATOR-CUM-MECHANIC (LIFT) A

Vacancy:- Total: 01 [One (01) vacancy is reserved for PwBD (OH)]

Age: - Below 35 years

Qualification & Experience: - Class VIII with ITI certificate of trade of electrician or equivalent or School Final or equivalent. Shall possess lift operator's license and permit equivalent to Electrical Wireman's Class (i) (b), with at least five years' experience in routine maintenance and operation of lifts in a reputed institution/company.

Age Relaxation: Upper age limit is relaxable by 5 years for candidates belonging to SC/ST and 3 years for OBC (Non-Creamy Layer) respectively in respect to the posts reserved for them. Relaxation of age for Ex-Servicemen, Persons with Benchmark Disabilities and departmental candidates (both internal and external) shall be as per Government of India guidelines.

- 1. The applicant must be a citizen of India.

- 5. Candidates called for the written test/ trade test will be reimbursed to and fro train fare by the shortest route in Second Class/Sleeper Class on submission of valid tickets.
- 6. In case of any inadvertent error in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to modify, withdraw or cancel any communication made to the applicants.
- 7. The Institute shall verify the documents submitted by the selected candidate(s) and his/her character & antecedents at the time of appointment or during the tenure of the service.
